<b>WOODCHIPPING SERVICES (EFFECTIVE JUNE 1, 2009)</b>	
<b>CHIPPING RATES:</b>	
No free minutes will be provided as in the past.	
Chipping to be billed at a rate of \$3.00 per minute to include a \$5.00 minimum charge.	
City crews to determine if the pickup would be more cost effective for the customer using the tractor or chipping.	
No stumps or bushes will be chipped.	
Trunk pieces to be no larger than 8 inch diameter and no longer than 3 feet in length.	
Chipping to be done on the first full week of each month.	
<b>HEAVY LIMB PICK-UP:</b>	
No free minutes will be provided as in the past.	
Heavy pick-up to be billed at a rate of \$4.50 per minute to be included a minimum charge of \$25.00.	
All limbs to be stacked with the ends facing the curb in a neat pile.	
No limbs over six feet (6') in length.	
Root balls are required to have the dirt removed prior to pick-up.	
Heavy pick-up to be completed the first week of each month following the chipping process.	
<b>LEAF PICK-UP (EFFECTIVE JUNE 1, 2009)</b>	
Leaves will be picked up on the third week of the month.
