Failure to resolve your citation (s) by selecting one of the following options before your scheduled appearance date may result in (1) Issuance of a warrant for your arrest and an ADDITIONAL CHARGE FOR FAILURE TO APPEAR (with a fine of \$316), (2) Denial of the renewal of Your Driver License and (3) An ADDITIONAL DPS NOTIFICATION FEE OF \$10 PER VIOLATION. The phone number captured may be used for future courtesy calls by the court. (ie. Appearance reminder, warrant pending notification, etc.) Please call the court to OPT OUT of receiving calls or text messages.

### **Your Options to Pay or Resolve This Citation:**

- **Schedule of Fines:** Visit [www.ci.sealy.tx.us](http://www.ci.sealy.tx.us) for full listing or see page 2. These are recommended window fines and subject to change per Judge.
- **Pay by Mail:** The Court accepts cashier's check or money order payable to: Sealy Municipal Court at no extra fee. Do **NOT** send cash. No personal checks accepted. They will be returned. See page 3.
- **Pay Online / By Phone with Credit Card:** Visit [www.ci.sealy.tx.us](http://www.ci.sealy.tx.us) 24 hours a day OR Call **1-800-444-1187** Monday through Friday from 8 am-7 pm and Saturday 9-2 pm. VISA , MASTERCARD, DISCOVER and AMERICAN EXPRESS accepted. Reimbursement service fees Apply to all credit/debit charges. Allow 3 days before attempting to make payment. See page 3.

## SCHEDULE OF FINES

Citation amounts include all State Court Costs as mandated by the state legislature. Fine amounts are determined by the judge and subject to change. Violations in work zone with workers present will double the fine amount. The amounts listed below are acceptable by the court when mailing payment. For a full listing of charges go to [www.ci.sealy.tx.us](http://www.ci.sealy.tx.us). If you are unable to pay the full amount of payment that is acceptable to the court, you may request a payment plan or to perform community service to discharge the full amount of costs, fine, and fees remaining by contacting the court.

If you are unable to pay, then the court will not process the plea bargain offer. You may request a payment plan or community service to discharge your case at this time. If this is not satisfactory, you have the right to request a jury or judge trial.

**Mail**  
We do **NOT** accept **PERSONAL/COMPANY** checks. They will be returned. You may pay your fine (s) by sending a cashier's check or money order made payable to Sealy Municipal Court. Do **NOT** send cash. Make sure to note your citation number on the document and fill out completely before mailing it to the court.

**Online**  
You may pay your fine (s) online at [www.ci.sealy.tx.us](http://www.ci.sealy.tx.us). We accept VISA, MASTERCARD, DISCOVER and AMERICAN EXPRESS. Reimbursement Service Fees apply to all Credit/Debit charges. Citations paid online must be paid in full. No partial payments, dismissal fines, or DSC payments will be allowed.

**By Phone**  
You may pay your fine (s) by phone by dialing **1-800-444-1187**. We accept VISA, MASTERCARD, DISCOVER and AMERICAN EXPRESS. Reimbursement Service Fees apply to all Credit/Debit charges.

**In Person**  
Allow 3 days before coming to the court. You may pay on or before your scheduled appearance date and time. We are located in the City Hall building at 415 Main Street in Sealy, TX 77474. We accept VISA, MASTERCARD, DISCOVER and AMERICAN EXPRESS. Reimbursement Service Fees apply to all Credit/Debit charges.

<b>Contesting Your Citation</b>
---------------------------------

**In Person**  
You may appear in person by your appearance date to enter a Not Guilty plea. This will place you on a pre-trial docket to speak with the prosecutor in person. The prosecutor does not do business over the phone or via correspondence. You must present a copy of your identification at this time.

**By Mail**  
You may select a plea of Not Guilty on page 2 and mail it to the Sealy Municipal Court by your appearance date. You must enclose a photocopy of your identification with your plea. Please make sure to sign, date and fill in the phone number prior to mailing your plea. The prosecutor does not do business over the phone or via correspondence.

**In Person**  
You may present the required proof on or before your scheduled appearance date for dismissal along with appropriate dismissal fine listed below.

**Mail**  
Prior to your scheduled appearance date, you may mail proof of compliance for the following violations:

1. **Insurance**  
Send a photocopy of the insurance policy that was valid at the time the citation was issued. You may present proof for yourself or the vehicle you were driving for dismissal.
2. **Driver License**  
No License on Demand: Send a photocopy of your proof of driver license appropriate for type of vehicle operated that was valid at the time of the stop along with a \$10 fine for dismissal of the charge.  
Expired Driver License: Send a photocopy of your proof of renewal along with a \$20 fine for dismissal of the charge.  
Failure to Report Name/Address Change: Send a photocopy of your proof along with a \$20 fine for dismissal of charge.  
Driver License Restriction/Endorsement Violation: Send proof restriction has been removed along with a \$10 fine for dismissal of the charge.
3. **Vehicle Registration**  
Expired Registration: Send a photocopy of your proof of renewal receipt along with a \$20 fine for dismissal of the charge. **You must disclose you received a citation and be sure to have paid the Late Registration Penalty fee on the receipt for it to qualify for dismissal. Failure to do so will result in the full fine being due. Permits excluded.**  
No Front/Rear License Plate Attached: Send a **photograph** of your proof along with a \$10 fine for dismissal of the charge.  
Illegible/Altered/Obscured /WrongPlate: Send a **photograph** of your proof long with a \$10 fine for dismissal of the charge.
4. **Defective Equipment: Non-Commercial vehicles only.**  
Provide photocopy of receipt of correction along with a \$10 fine for dismissal of the charge.
5. **Expired Disabled Parking Placard**  
If expired less than 60 days, you may provide proof of the renewal along with a \$20 fine for dismissal of the charge.

If you miss your original scheduled appearance date, the court will schedule you for a second appearance date within the following 30 days. Failure to appear by your scheduled second appearance date will result in:

1. A warrant issued for your arrest (\$50 warrant fee plus additional fees);
2. A separate charge of Failure to Appear filed (\$316);
3. Denial of Driver License issuance or renewal;
4. Referral to a third party collections vendor which will result in an additional collection fee of 30% of total fine.

Inability to pay the fine is not an excuse for failing to appear. If you are unable to pay the full amount of payment that is acceptable to the court, you may request a payment plan or to perform community service to discharge the full amount of costs, fine, and fees remaining. If these options are an undue hardship, you must contact the court immediately. Alternative methods may apply.

<b>Juvenile Appearance Requirements</b>
---

If you are a juvenile (under 17 years of age) and you have been charged with a Penal Code or City Ordinance violation or a traffic citation, State Law requires that you must appear in Court with a parent or legal guardian. You may not pre-pay your fine or request DSC by mail. You will be receiving a parental summons by mail with a new juvenile docket appearance date. **Please contact court immediately if the address on citation is incorrect.**

<b>Juvenile Warning</b>
-------------------------

**A child and parent required to appear before the Court have an obligation to provide the Court in writing with the current address and residence of the child. The obligation does not end when the child reaches age 17. Before the seventh day after the date the child or parent changes residence, the child or parent shall notify the Court of the current address. A violation of this subsection may result in arrest and is a Class C misdemeanor.**

# Driving Safety Course (DSC) Request

(Taking this course will keep violation off your driver record.)

## Instructions

You must request DSC (**not take the course**) on or before your appearance date or you will lose the right to elect it at a later time. It is too late to elect DSC at trial. Please allow 3 days from the date the citation was issued to make your request in person. **DO NOT pay the fine if you are requesting DSC.** You only pay the appropriate fee below.

### You are NOT eligible to take DSC if:

- You hold or held a Commercial Driver License at time of the stop;
- You have taken DSC for another citation dismissal within one year from the date of this citation;
- You are charged with:
  - 95 miles per hour or more; or
  - Speeding 25 miles per hour or more over the posted speed limit;
  - Passing a school bus;
  - Committing a serious traffic violation;
  - Failing to stop and provide information or render aid after an accident;
  - Committing an offense in a construction zone when workers present.**
- You do not have a valid Texas Driver License or personal proof of liability insurance.

### ITEMS TO MAIL OR BRING TO COURT FOR DSC REQUEST

- Photocopy of your current auto liability policy.
- Photocopy of your valid TX Driver License.
- DSC Fee as indicated above.
- Completed and notarized DSC application.  
*We can notarize for you here in person.*

**MAIL** - You must send the before mentioned documents along with the application completed and notarized. Failure to send in all documentation with the application will VOID your request. Failure to have the envelope post marked by your appearance date will VOID your request. The judge will accept your plea and partial payment and enter a conviction on the charge filed against you. No exceptions.

**IN PERSON** - You may apply for DSC on or before your scheduled appearance date. You may pay with cash, money order, cashier's check, VISA, MASTERCARD, DISCOVER AMERICAN EXPRESS at the window (Reimbursement Service Fees Apply on Credit/Debit Charges). The court can notarize your application for you upon your request.

**\*\*\*Upon the court's receipt of your request, you will have 90 days to:**

- Complete a DSC. **Do not take it prior to filing your request with the court;**
- Order a certified copy of your driving Record from Texas Department of Public Safety at [www.texas.gov](http://www.texas.gov);
- Submit your certificate of completion of the course (Court's Copy) **SIGNED** and the copy of your driving record. (If you use the court's application for driving record, the record will be mailed directly to the court for you.)

If you fail to comply with any of the above-stated requirements, you will have a conviction entered against you and you will be required to pay the remaining fine amount due. Failure to pay this fine amount will result in an additional \$15.00 Time Payment Reimbursement Fee and the issuance of a capias pro fine warrant for your arrest.

Appeals must be filed within 10 days of judgment to be perfected.
